Kiwanis International named Col. Donald Gray Heppner Jr., M.D. as its 2009 World Service Medal recipient. Heppner, deputy commander of the Walter Reed Army Institute of Research (WRAIR), was honored for his critical role in the development of a promising vaccine against malaria, one of the world's most devastating diseases of children. The Kiwanis World Service Medal, established in 1985, recognizes individuals who devote a significant part of their lives to meeting the needs of others.

ROBERT P. CONNELLY MEDAL OF HEROISM

The Kiwanis International Foundation awarded its Robert P. Connelly Medal of Heroism to Ryan Jorgenson of Sioux Falls, South Dakota, USA, who saved the life of a teenager, paralyzed from the waist down, from drowning after a wave swept him off his family's boat.
